

# 2025 ADULT LEADER BACKGROUND CHECK STATEMENT OF COMPLIANCE

**This form is turned upon arrival at Super Summer Kids on-site registration.**

All Churches and groups participating in Super Summer Kids understand that any and all volunteers and/or adult leaders they bring are their responsibility. As part of this responsibility, each Church or group bringing such volunteers and/or adult leaders will ensure that, prior to their arrival, each volunteer and/or adult leader will have passed the appropriate level of background screening (as provided by Florida law, rule or regulation). The Churches understand that, depending upon the context, custodial supervision of minors in a summer-camp setting may now require level-2 screening.

The volunteering adult leaders named below are known to the staff or recognized leadership of the participating church and the church knows of no reason why any should not serve as an adult leader for children and youth under the age of eighteen (18). Furthermore, in consideration of being allowed to attend Super Summer Kids camp, the church hereby agree to indemnify and hold harmless Lake Yale Baptist Conference Center and the Florida Baptist Convention, their agents or employees, against any and all causes of action, rights, claims or suit which may be against LYBC and the FBC, or their agents or employees as a result of the church's negligence in the selection and/or supervision of adult leaders.
